DFRDB UPDATE – AUGUST 2026

Government Response to the Senate FPA References Committee Report

The Government has responded to the Senate Finance and Public Administration References Committee has released its Report into the Operation and appropriateness of the superannuation and pension schemes for current and former members of the Australian Defence Force (ADF).

What the Response means for you

The Government's Response confirms that **no legislative or financial remedy will be provided to DFRDB members**, despite the Senate Committee's findings and despite Senator Lambie's additional recommendations. The Government explicitly states it is "**satisfied that the [DFRDB] scheme is operating as intended**" and rejects all proposals that would correct or compensate for the long-running detriment caused by commutation and outdated life-expectancy factors.

The Government relies heavily on the 2019 Ombudsman report, which acknowledged defective administration but concluded that commutation was "generally to the benefit of members". The Government repeats this position and uses it to justify **not changing the law, not updating life-expectancy tables, and not creating any new compensation mechanism**.

The only avenue the Government acknowledges for affected members is the existing **CDDA Scheme**, stating:

"DFRDB complainants have access to this particular service."

However, the Government does **not** commit to compensating any member and does **not** accept Senator Lambie's recommendation that compensation should be provided "where evidence demonstrates that defective administration materially influenced retirement decisions resulting in financial detriment."

These materials outline the legislated detriment experienced by DFRDB members for decades, detriment that cannot be dismissed as administrative error nor remedied through the CDDA scheme. Please confirm that you can access them.

The video illustrates how permanent commutation reductions, outdated 1960–62 life tables, and indexation applied to a diminished base have eroded retirement pay, invalidity benefits, spouse pensions, and dependant entitlements. The *Misleading Defence Narrative* sets out the pattern of ministerial and departmental responses that have minimised, deflected, or mischaracterised these concerns for more than 25 years.

The cost of rectifying these long-standing injustices is relatively small and need not impact the Budget. A modest allocation from the annual earnings of the Future Fund, which exists to meet unfunded Commonwealth superannuation liabilities, including DFRDB, would fully cover the cost of rectification.

DFRDB members, who dedicated decades of the prime of their lives to the service of their country, do not deserve the ongoing erosion of their entitlements and should no longer have to tolerate this deception.

Unless the Coalition publicly commits to a clear policy to rectify these long-standing injustices, we will mount an extended campaign, aimed at the more than 5,000 members of our Association, the members of more than 400 other Ex-Service Organisations, serving defence force members, and their families, encouraging them **to direct their votes away from and place the Coalition last on their ballot at the next election**. This is not a threat; it is the inevitable consequence of decades of inaction on an issue that affects the financial security and dignity of those who served.

I look forward to our meeting and to discussing how these matters can finally be addressed.
